

This unique ownership structure ensures that 40% of the firm's dividends are directed to medical research. Accordingly, ACI adheres to a dual mission of helping clients achieve their financial goals while striving to have a positive impact on humankind.


Engagement



Proxy Voting Overview

In 2021, the Sustainable Equity Fund supported 99% of the 130 ESG shareholder resolutions. ESG proposals are generally supported when they are well-targeted and there is a rational link between the proposal, its economic impact and its potential to maximize long-term shareholder value. The percentages of these proposals broken down by Environmental, Social, and Governance themes are shown below along with some of the notable resolutions supported.


